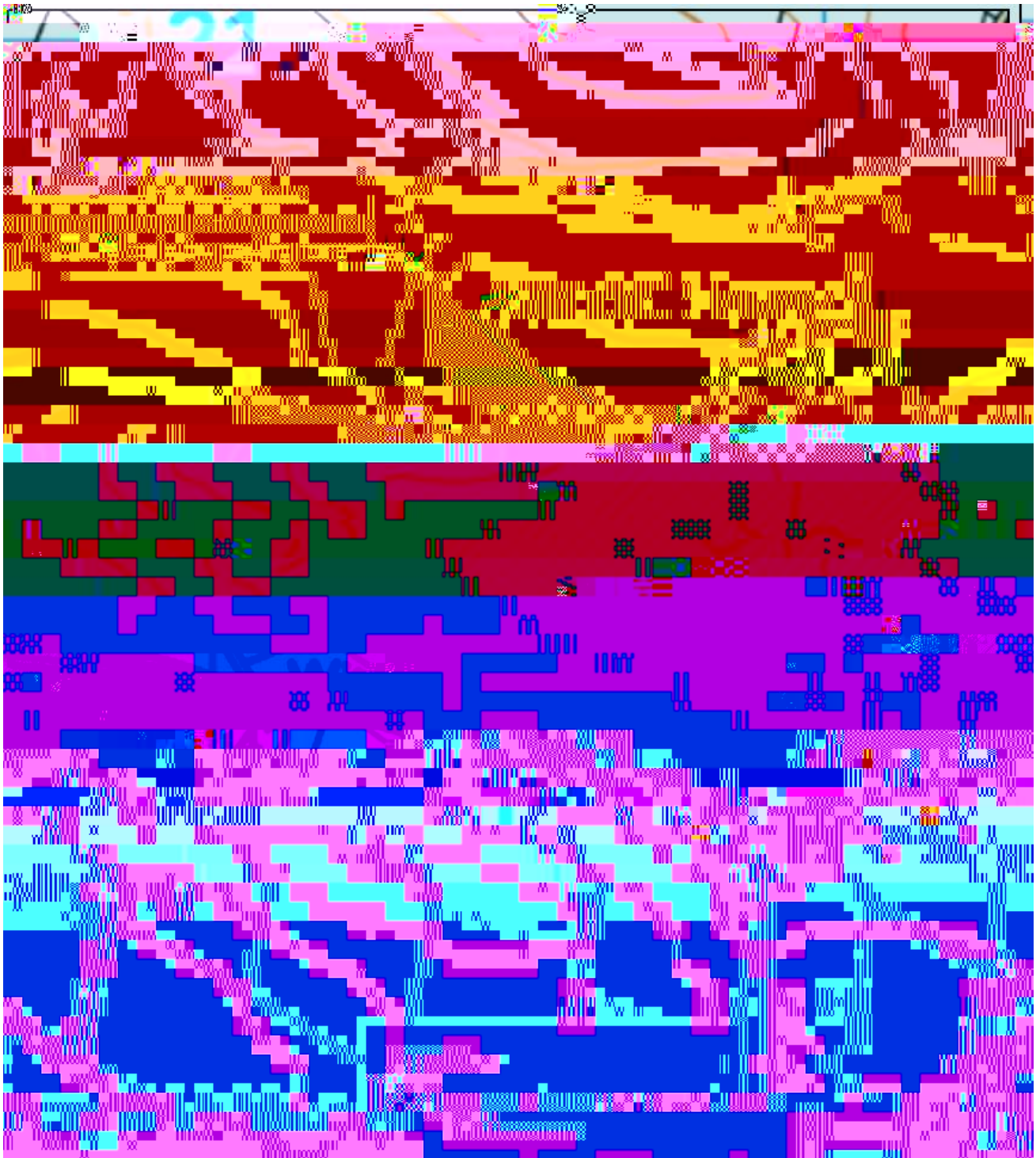

Location of land to be Exempted: Kintyre Show

Argyll and Bute Council grants an order to exempt the land identified above and shown delineated in red on the accompanying map for the purposes and time shown below from the access rights which would otherwise be exercisable in respect of that land by virtue of the Land Reform (Scotland) Act 2003. This includes any parts of Core Paths or Public Rights of Way recorded within the area Marked in Red on the attached map.

Purpose of Exemption :

To charge a fee for entry, to prevent public interference with the event and to prevent the public from affecting the safety of the participants or spectators

This Order shall have effect for a period of 1 day starting;

Friday, 02 August 2024 - 0800hrs to 18.00hrs

unless revoked earlier.

A copy of the attached Notice of making of an Order to Exempt Land from Access Rights and the accompanying map of the excluded land must be displayed at each entrance point to the land in question for the entire duration of the exclusion.

This Order is issued under the Land Reform (Scotland) Act 2003 and neither gives nor implies any other permission or consent that may be required. This notice does not carry with it any rights to exclude any land that is not described on it or shown on the accompanying map.
