## 1. Introduction

The Harbour Consultation Policy is designed to ensure that the Council's Statutory Harbour at Bruichladdich Pier, by virtue of the 'Islay Piers Order' (X), is managed in a way that respects the views and concerns of local residents and businesses. The policy aims to promote transparency, engagement, and effective communication throughout the consultation process.

Under the 'Islay Piers Order', the Council is required to consult with the public on proposed changes to the harbour infrastructure and operations.
