Site Description

This large site is located in an area of Panoramic Quality and within the $\mathbb{C} < 7fU[m] \ d^*UbX@7H^*$

The ROA runs from Blarchasgaig in the west to Creagan in the east along a wide, shallow valley. It is dissected in its middle area by the A828, which also forms the northern boundary in the western areas and the southern boundary in the eastern areas. Two minor roads lead south through the ROA at Blarchasgaig and Inverfolla. A disused railway, roughly following the line of the A828 runs throughout the ROA. The highest point of the site is the northern end along the An t-Seana-chroit at 60m AOD.

There are a number of dwellings within the site, cottages at Blarchasgaig, a linear development of small cottages at Druim-na-moina, farmsteads at Inverfolla and Invernahyle and a holiday park with wooden chalets and restaurant at Creagan.

At its eastern end the ROA comprises steep scrubland with a large area of commercial forestry. The central area is much more open with views opening up in all directions. At the western end the ROA narrows along the roadside and views are dominated by Loch Creran to the south.


